Dem Candidates

Constitutional Amendments

#1- NO- Partisan Election of District School Boards would make children's education even more political.

#2-NO- the **Right to Fish and Hunt** is already allowed; prevents best wildlife management practices.

#3-YES- Legalizes **Adult Personal Use of Marijuana** for limited non-medical use and licensed distribution.

#4-YES- Limit Government Interference with Abortion so health care is between a woman & her Dr. Current law is extreme with no real exceptions.

#5-NO- this **Homestead Annual Inflation Adjustment** drains local funds by \$23 million now and \$112 million later.

#6-NO- Repeal of Public Campaign Financing would benefit candidates that are wealthy or get big \$ gifts.

City Charter Amendments

#1-NO- Raising Salaries of City Commissioners Annually based on population with no cap or reference to budget is irresponsible.

#2-YES- Expanding Jurisdiction of the Ethics Board over city commissioners serving on other agencies such as Blueprint ensures ethical oversight of important decisions.

#3-NO- Resolving 2 Candidate Elections at the General Election would make it cost more to run for office.

#4-YES- Periodic Charter Review keeps it relevant.

#5-YES- Defining the Role of Inspector General in the Charter preserves IG role and independence.

IDs and Where, When, and How to VOTE!

If you can, **Vote Early, Oct 21- Nov 3**, because if there's a problem, there's time to fix it. Places & times below.

To vote in person, bring ID w/ photo and signature, or 1 ID with each. Allowed IDs: FL driver license or ID, debit or credit card, military or student ID, public assistance or government employee ID, passport, weapons permit, VA health ID, or retirement center ID.

Vote Early or put your mail-in ballot in a drop box at any of these Leon County sites:

To vote on Election Day, you must go to your assigned polling place, which may have changed. To check, call the Supervisor of Elections at 850-606-8683 or look up your voter info on [their website](#).

To vote by mail, you MUST sign and date in the box on the return envelope. Also, write your email and phone number so Elections can reach you if there's a problem.

Return your ballot ASAP. If you mail it, send it right away. If possible, take it to the Elections Office 8:30-5:00 Mon-Fri **OR** take it to an Early Voting Drop Box during voting hours.
