# **Voting and Assistance**

#### **Vote Early!**

The most reliable way to vote is in person at any early voting site. When you vote early, if there's a problem, there's time to fix it. **Bring the right ID.** 

If you vote in person, <u>bring an ID</u>: FL driver license or FL ID or a debit card or credit card, military or student ID, veteran health ID, govt employee ID, passport or concealed weapon license with your photo & signature, or bring 1 with photo & 1 with signature.

#### **Early Voting is August 13 - 21**

#### **Vote in person on Election Day**

Some precincts have changed; check your voting card for where to vote or call: 850-606-8683 or look online at LeonVotes.gov Be sure to bring the right ID.

#### Vote by Mail

To request a mail ballot, call: 850-606-8683 or go to <u>Leon-Votes.gov</u>. Fill it out following the directions. On your green return envelope, write your phone # and email address so the elections office can reach you if they find a problem.

Mail your ballot right away, or, starting August 13, take it to an Early Voting drop box during voting hours. The sooner you return the ballot, the more time the Supervisor of Elections has to help you fix any problems.
